SECONDARY SCHOOL CERTIFICATE (9TH & 10TH) SUPPLEMENTARY EXAMINATION, 2015

It is hereby notified for the general information of all concerned that the Secondary School Certificate (Supplementary) examination, 2015 of BISE, Kohat, will commence on **Tuesday, 25th August, 2015**. Only Reappear/Failed candidates of SSC and candidates of Oriental Languages Examination are allowed to appear in the said exam. As per decision taken by KPBC meeting no. 132 dated 2nd July 2013 vide Item No. 4, the candidates failed in paper / papers of 9th class but promoted to 10th class are allowed to appear in this failed paper / papers in subsequent supply examination. Fresh candidates bearing School Leaving Certificates will not be allowed to appear.

Computerized admission forms of the Board will be available in all the Camp Offices within the jurisdiction of this Board and Admission Fee May be deposited in The nearest branches of National Bank of Pakistan for BISE Kohat, the Original receipt of which should be attached with admission form.
