All Private candidates must attach photocopies of DMCs, Domicile/CNIC (self/father) and Original Bank Receipt.

The subject passed with grace marks/aggregate must be included in the improvement subjects and if the candidate has not included that particular subject, the candidate will be considered as MNI (Marks Not Improved).

Part-I Private Fresh candidates are not eligible to appear in the HSSC Supply Exam 2017.

As per decision in KPBCC Meeting No.156 Dated 25-07-2017 at BISE, Swat vide item no. 9, those candidates who cancel one or two paper(s) are not allowed to appear in the HSSC (Supply) Exam 2017. Rather they will appear in the cancelled paper(s) alongwith part-II in the HSSC (Annual) Exam, 2018.

 No admission form under any circumstances will be accepted either by post or by hand after the prescribed date i.e. <u>25-09-2017</u>.
